Kendall County Health Department Services

Behavioral Health Services

❖ **ADDICTIONS TREATMENT**

Outpatient addictions treatment delivers comprehensive clinical services that are designed to help individuals stop compulsive drug and alcohol usage while developing improved whole health and well-being. Treatment services are designed to address both substance abuse and mental health issues in an integrated manner. Treatment modalities include individual, group, and family counseling at different levels of intensity so that individuals with multiple diagnostic features may be served.

❖ **CHILD CENTERED THERAPY**

Specialized child centered therapy treatment works to help children communicate and resolve challenges related to mental health problems or areas of duress. Interventions are tailored to meet the unique developmental and social-emotional level of the individual child and may also include play therapy strategies. Child therapy services help the child learn to relate to others, master new skills, develop rule governed behaviors, and to achieve a better sense of self. Family services are integral to the treatment process.

❖ **COUPLES COUNSELING**

Supportive couples counseling works to assist those in a relationship or marriage to identify and resolve conflicts in efforts to promote an improved and healthier relationship. Treatment is designed to promote improved collaborative problem solving skills, promote effective communication, develop effective conflict resolution strategies, and to help repair, rebuild, and develop relationship status.

❖ **DOMESTIC VIOLENCE**

Clinical services designed to ensure safety and mental health well-being for those affected by domestic violence. Treatment includes individual and family counseling treatment for all those who may have been impacted by domestic violence. Safety planning and comprehensive case management services are integrated during the treatment process to assist with housing, financial, and legal supports.

❖ **ELDER COUNSELING**

Dignified elder counseling services work to support elders in maintaining community independence and in the promotion of emotional well-being. Services are designed to promote social connectedness to meaningful community networks inclusive of family. Elder counseling also strives to assist elders in addressing issues related to stressors that can sometimes result from life changes such as loss of spouse, increased health needs, and socio-economic challenges.

❖ **FAITH-BASED SUPPORT**

Our faith-based support services work to assist local faith-based organizations by providing psycho-education, targeted outreach to high risk populations, and through development of culturally relevant flyers and brochures about mental health services.

❖ **GRIEF COUNSELING**

Healing grief and bereavement counseling seeks to assist the individual in understanding that sadness is an important part of the grieving process and to develop strategies to cope with and experience one's emotions in a healthy manner. Counseling works to assist the individual with the grief and bereavement process while working to adjust and thrive in current life circumstances.

❖ **PARENT EDUCATION**

Diverse parent education services draw upon the unique experiences and expertise of the parents and supplement their strategies with psycho educational information that is meaningful and culturally relevant. All parent education services provide strengths based approaches to assist with clear and consistent limit setting, effective communication, identification of risk factors that could lead to poor behavioral health outcomes, and promotion of protective factors to support children's whole health and well-being.

Behavioral Health Specialized Supports

❖ Youth Mental Health Treatment Groups

Youth counseling groups developed using feedback received from community partners in Kendall County schools, as well as through identification of high risk factors faced by youth already engaged in treatment. These groups are gender specific and designed for adolescents in the 6th, 7th, and 8th grades. The girls group is GRACE, which stands for Girls – Resilient – Accomplished – Competent – Empowered. The boys group is BRAVE, which stands for Boys – Resilient – Accomplished – Virtuous – Empowered. These groups help youths to develop skills in the areas of personal growth and development, mental health resilience, healthy social connectedness, whole health and wellbeing, and emotional efficacy. These groups are rooted in evidenced-informed practices and have a family participation component in the curriculum.

❖ Veterans Mental Health Treatment

We are working closely with the Veterans Assistance Commission of Kendall County to promote and provide affordable, accessible mental health and substance abuse treatment to our local veterans and their families. This collaboration has resulted in an increased number of veterans receiving treatment mental health, substance abuse, and psychiatric treatment services in their county of residence.

❖ Substance Abuse Peer Support

The Health Department has incorporate speakers from both Alcoholics Anonymous (AA) and Narcotics Anonymous (NA) into substance abuse treatment services. The process of recovery from alcohol and substance abuse is supported through healthy relationships and social networks. That being said, it is sometimes difficult for the person in treatment to actively seek additional healthy supports. Persons dealing with an alcohol and/or narcotics addiction, including opioids, have expressed meaningful connection and support from these community based peer supports. Persons served will gain awareness and access to healthy community supports to promote their wellbeing both during and after the treatment process.

❖ Trauma Focused Services

Health Department staff have expanded their knowledge and focus on the provision of trauma-induced-stress related treatments; a cornerstone to fostering community resilience. This includes the addition of trauma-focused questions on the Health Department’s psychosocial assessment to ensure that those individuals who have experienced or witnessed trauma have specific interventions that are both effective and meaningful.

❖ Youth Behavioral Health Coalition

A community-based coalition focused on mental health, substance abuse, and the overall wellbeing of youth and families in Kendall County. This coalition is comprised of diverse community partners including schools, youth serving organizations, and health care providers. The intent of this coalition is to share resources for comprehensive mental health wellbeing and to identify any trends or gaps in service. This coalition also serves to further strengthen a well established and productive partnership between Kendall County school social workers and the Health Department’s mental health professionals.

❖ School Based Counseling Services

Kendall County schools, public and private, are offered the opportunity to have a Mental Health and Substance Abuse Treatment Clinician present at their school for a two hour time period, one day per week; individuals to be served are children and youth unable to access treatment at the Health Department’s Yorkville location. Schools are served on a pre-established rotation to ensure equity throughout the county. This special service is intended to promote access to treatment by helping to remove any potential barriers to the treatment process.

❖ Crisis Prevention Training

We offer comprehensive crisis prevention training that is designed to promote early recognition of potential crisis indicators and strategies for ensuring the safety of all those involved in a crisis situation. Training provides education on the importance of surveying the scene, the ability to recognize precursors that may lead to aggressive behavior, how interpersonal interactions may impact behaviors of persons served, violence prevention, and effectively responding to threatening circumstances.

❖ Re-entry Care Coordination

Specialized treatment and re-entry care coordination for individuals in the criminal justice system with behavioral health and substance abuse treatment needs. Licensed treatment clinicians provide substance abuse treatment and behavioral health psycho-education to incarcerated inmates at the Kendall County Jail. Re-entry care coordination services are designed to promote continuing care either in the community in which the individual resides or for in-prison continuing care services. Re-entry care coordination services work to promote an awareness of the individual’s behavior on victims, family members, and the community to help restore or repair damage that has been done when criminal acts were committed. Services are designed to reduce risk of relapse in areas of substance abuse and other high risk behaviors and to reduce likelihood of recidivism.

Community Action

❖ **DRIVE TO SUCCESS PROGRAM**

The program is designed to help low income people obtain reliable transportation for employment purposes and is funded through Community Service Block Grant Department of Commerce & Economic Opportunity. KGCA will provide assistance for vehicle repairs.

❖ **EDUCATION SCHOLARSHIPS**

The KGCA scholarship program awards scholarships annually to clients to aid them in obtaining formal education or occupational training from an accredited Illinois institution.

❖ **EMERGENCY SERVICE**

KGCA Emergency Service Program provides intake and referral to persons in crisis situations to assist with their emergency/crisis situation.

❖ **EMPLOYMENT SUPPORT**

Employment Support Service Program provides intake and referrals to low income persons in crisis situations to have their emergency needs ameliorated.

❖ **ENERGY ASSISTANCE**

Low-Income Housing Energy Assistance Program (LIHEAP) helps income eligible households meet their residential heating and cooling costs. Additional funding through NICOR Sharing Program and ComEd Special Hardship Program is available for clients who have suffered financial hardships due to high medical bills, military service, or other hardships. The assistance is one-time only.

❖ **HELPING HANDS FOR SCHOOL**

This program assists eligible parents to purchase their child's prescription glasses.

❖ **RESIDENTIAL WEATHERIZATION**

Weatherization services are designed to help low income residents save fuel and money while increasing the energy efficiency of their homes. Energy conservation education for local homeowners is an important part of each weatherization project.

Community Health

❖ **COMMUNICABLE DISEASE (CD) AND SEXUALLY TRANSMITTED DISEASE (STD) PROGRAMS**

These programs protect and promote the health of Kendall County residents. Nurses in the Communicable Disease Program and Sexually Transmitted Disease Program are diligent in their surveillance, reporting and follow-up, thereby resulting in a lower number of illnesses seen in the Community.

❖ **FAMILY CASE MANAGEMENT (FCM)**

This State Grant Program is a comprehensive program that assures easier access to medical care and provides linkage to support services for pregnant women, mothers, and infants.

❖ **HEALTHWORKS**

This program provides medical case management services for all foster children residing in Kendall County under the age of 6. HealthWorks also maintains a network of physicians, dentists, and specialty care doctors who provide medical care for these children. HealthWorks is funded through the State of Illinois as part of DCFS.

❖ **IMMUNIZATION PROGRAM**

This program provides necessary immunizations to infants, children, and adults at minimal or no cost to protect Kendall County residents from vaccine preventable diseases. Flu vaccine and pneumonia vaccines are also available.

❖ **TB CLINIC**

Community Health Services provides Tuberculosis screenings and referrals for treatment. Direct Observed Therapy (DOT) visits are also provided to ensure clients are taking their Tuberculosis medications as prescribed.

❖ **TRAVEL CLINIC**

Exotic shots, as needed for travel outside the United States, are available upon requests. Call the Health Department at (630)-553-9100 for vaccine information. Appointments are required for the Travel Clinic.

❖ **WOMEN, INFANTS AND CHILDREN (WIC)**

WIC is a Supplemental Food and Nutrition Program funded through the Federal Government. In Illinois, over 40 percent of all babies born are on the WIC program. Recent studies have shown that WIC participation reduces fetal deaths, infant deaths, low birth weight babies, and iron deficiency anemia.

❖ **EMERGENCY PREPAREDNESS AND RESPONSE**

Emergency Preparedness is of critical importance to KCHD as it encompasses many of our daily public health operations and prepares the department to respond should those daily operations turn into emergencies that threaten the well-being of the public. Emergency preparedness means being ready if a disaster strikes. It entails the coordination of partners, resources, response operations, and communication to protect the health of Kendall County citizens.

Environmental Health

❖ **BODY ART INSPECTION**

Reviewing plans for, inspecting the operations of, and educating all State licensed tattooing and body piercing businesses.

❖ **FOOD PROTECTION**

Reviewing plans for, permitting and inspecting, and educating and regulating the activities of all food service establishments, cafeterias, mobile food vendors, food caterers and commissaries, and temporary food events throughout Kendall County.

❖ **INDOOR AIR QUALITY**

Providing education and guidance to homeowners on the prevention and mitigation of conditions of indoor mold, and the testing for and mitigation of indoor radon gas.

❖ **PRIVATE/SEMI-PRIVATE POTABLE WATER SUPPLY**

Reviewing plans for, and permitting and inspecting the construction of, new and repaired private water wells, and water well abandonments. Additionally, performing or providing guidance on the sampling and testing of private water supplies.

❖ **PRIVATE SEWAGE DISPOSAL**

Reviewing plans for, and permitting and inspecting the construction of, new and repaired septic systems. Also included are plat review of proposed residential subdivisions, Certificate of Occupancy and property transaction inspections, and the inspection of sewage pumping/hauling vehicles and associated sewage land application sites.

❖ **PRIVATE WATER WELL EDUCATION AND MAPPING**

The locations of private water wells are field-verified and mapped using Geographic Information System (GIS) technology. Owners are provided education on the proper operation and maintenance of their water well and the protection and preservation of their water supply.

❖ **NON-COMMUNITY WATER SUPPLY**

Performing routine inspections, and water supply sampling and testing of all private, non-community water supply systems (i.e., serving restaurants, taverns, churches, etc.) located within the County.

❖ **NUISANCE COMPLAINT INVESTIGATION**

Includes the investigation and resolution of select public and environmental health-related complaints registered with the Department. Categories include but are not limited to air, land and water pollution; open burning, improper storage and disposal of garbage and refuse; stagnant water, the harborage and/or breeding of vermin.

❖ **SOLID WASTE & RECYCLING**

Includes the permitting and inspection of solid waste haulers and pollution control facilities doing business in Kendall County, maintaining and promoting County-wide recycling efforts, and investigating solid waste related complaints. The program is also responsible for maintaining the County's State mandated Solid Waste Management Plan.

❖ **TANNING FACILITY INSPECTION**

Reviewing plans for, inspecting the operations of, and educating all State licensed tanning facilities located within the County.

❖ **VECTOR SURVEILLANCE**

Investigating and eliminating potential breeding sites for, and providing education on the prevention of tick and mosquito-borne diseases. Collecting and testing mosquitoes and dead birds for the presence of the West Nile virus. Environmental Health serves as a hub of information to multiple County jurisdictions.
